The Union Cabinet approved the Pradhan Mantri Kaushal Vikas Yojana (PMKVY) on 19 March 2015 with an outlay of Rs. 1500 crore. The programme aims to impart skill training to youth with focus on first time entrants to the labour market and class 10 and class 12

### Key characteristics of the Pradhan Mantri Kaushal Vikas Yojana (PMKVY)

•The programme aims to impart skill training to youth with focus on first time entrants to the labour market and class 10 and class 12 drop outs.

• The scheme will cover 24 lakh persons and skill training would be based on the National Skill Qualification Framework (NSQF) and industry led standards.

• The programme will be implemented by the Union Ministry of Skill Development and Entrepreneurship through the National Skill Development Corporation (NSDC) training partners.

• In addition, Central and State Government affiliated training providers would also be used for training purposes.

• Skill training would be on the basis of skill gap studies conducted by the NSDC for the period 2013-17.

• Focus of the training would be on improved curricula, better pedagogy and better trained instructors.

• Training would include soft skills, personal grooming, behavioural change for cleanliness, good work ethics.

• A monetary reward will be given to trainees on assessment and certification by third party assessment bodies. The average monetary reward would be around 8000 rupees per trainee.

### **Funds Allocation**

• A total outlay of Rs 1120 crore has been made on skill training of 14 lakh youth.

• Rs. 220 crore

• Rs 67 crore have been allocated for awareness building and mobilization efforts.

• Rs 67 crore have been allocated for mentorship support and placement facilitation for trainees.

• From the total outlay, Rs 150 crore have been allocated for training of youth from the North-East region.

#### Role and Responsibilities of MSSDS.

1.Mobilization of students: The MSSDS as a nodal agency for implementing the PMKVY in the State will take up the responsibility of mobilization of students with the support of training partners for enrolment in various skill based training courses aligned to their career aspirations. This activity would be supported through awareness and communication campaigns run by MSSDS at all assembly constituencies.

2.Budget Allocation: The MSSDS will be responsible for obtaining and managing the PMKVY funding for the project implementation.

3.Empanelment of NSDC Training Providers: The MSSDS will empanel NSDC training partners who fulfill all the relevant criteria as desired by the relevant ongoing schemes of the state. The Training Partners will align their contents and curriculum as per the Industry defined Qualification Packs (QP) and National Occupational Standards (NOS) set by the NSDC approved Sector Skill Councils.

4.Administrative Support: The MSSDS will upload the data related to students enrolment and training on SDMS and share details with NSDC pertaining to skill based courses on a monthly basis.

#### Roles and Responsibilities of NSDC and SSC

1.Identification and finalization of Sectors: NSDC will identify Sectors for execution of skilling in the state of Meghalaya by various departments.

2.Mapping of courses on NSQF: The sectors and job roles selected for skill based training in various schemes will be based on various levels mapped according to National Skills Qualification Framework (NSQF). The mapping of the same will be undertaken by Sector Skill Councils.

3.Accrediting curriculum: Sector Skill Councils will review the available curriculum and accredit the one best suited for the program - both for the students and trainers on the basis of guidelines set by NSDC and the SSCs.

4. Training of Trainers: NSDC (either itself or through its approved Sector Skill Council) will take the responsibility of doing quality control of the training including providing the Master Trainers for the teacher training of the training partner and existing trainers of the state.

5.Assessments and Certification: The trainees undergoing the various skill development schemes will be assessed by the designated assessors of Sector skills council. Sector skill councils will ensure timely assessment of skills of MSSDS and Livelihood School trainees and will issue a joint certification with MSSDS pertaining to the National Skill Qualification Framework Level.

6.Industry Interface: NSDC through its training partners, if appointed will facilitate industry interface, identifying local industries who will actively engage to help the delivery of the training and placement of

# The entire process from enrolment to money transfer for a fully certified trainee:

Please find below the process divided into flowing steps:

1. Trainee to enroll at a training center with a training partner and select a course of his preference

2. Trainee to provide relevant information to the Training Partner who captures all the candidate details on SDMS to facilitate training

3 Undergo assessment at the training center

4. Receive certificate from the training partner upon successful completion of assessment

5. NSDC to disburse monetary reward to passed and certified trainees subject to valid Aadhaar authentication

#### Enrollment for a course

• The trainee can call the NSDC Call Centre number on +91 88000-55555 or check for the Training Center on the PMKVY website to find the nearest Training Center. Any eligible candidate can get registered with any of the approved Training Providers for the approved courses. Training Partner captures all the candidate details in the SDMS system and facilitates the training. District wise Kaushal Melas are also being organized by Training Partners for mobilization and enrollment. You may check the PMKVY website for more details.

### Eligibility criteria for the trainee to enroll for a course

This scheme is available to any person of Indian nationality who:

1.Undergoes a skill development training in an eligible sector by an eligible training provider

2.Is certified during the span of one year from the date of launch of the scheme by approved assessment agencies

3. Is availing this monetary award for the first and only time during the operation of this scheme

# Age limit for the trainees to be enrolled under the Scheme

• There is no age criterion under the Scheme. However, the minimum and maximum eligibility for the course is mentioned in the Qualification Pack of the course and must be adhered to.

# Placement assistance provided by the Training Partner

• Training is intended to develop and certify skills against industry standards. It is to be viewed as an opportunity to become employable. The scheme in itself doesn't guarantee any placement. However, the Training Partner may provide placement assistance.

• For trainees whose assessment results have been announced/uploaded on SDMS, the next step is certificate generation. If a trainee has received his/her assessment result from the training partner, then they are required to follow up with the training partner for the certificate also.
